## Chair's Foreword

he Joint Standing Committee of the Corruption and Crime Commission of the 40<sup>th</sup> Parliament was only established on 15 June 2017. Accordingly, this report deals almost entirely with the work of the Committee of the 39<sup>th</sup> Parliament.

At the stage Parliament was prorogued there were a number of reports that, although tabled, had not yet been the subject of a Government response and have needed to be revisited by the new Committee.

In this context it is worth noting that this Committee comprises of members who are unfamiliar with the detail of previous deliberations as they did not serve in this role in the last Parliament.

Clarification of the requirements for the composition of the Committee, the capacity to oversight investigations of minor misconduct by the Public Sector Commissioner and doubts expressed of the power of the CCC to investigate members of Parliament are all live issues confronting the new Committee.

These matters will be addressed in reports tabled in the coming months including identification of legislative or standing order changes required.

## **Chapter 1**

### Committee's activities

#### Introduction

The 2016–2017 reporting period encompasses two parliamentary sessions. The 39<sup>th</sup> Parliament was prorogued on 30 January 2017 and the Legislative Assembly was dissolved by the Governor on the same date. This dissolution terminated the Legislative Assembly and its committees, including joint committees. The Joint Standing Committee on the Corruption and Crime Commission (the Committee) of the 40<sup>th</sup> Parliament was established on 15 June 2017.

During the period between 1 July 2016 and 30 June 2017, the Committee:

- held 12 deliberative meetings;
- took evidence from 13 witnesses at five hearings;
- met with 17 people at eight briefings;
- undertook investigative travel to Sydney, Melbourne and Wellington, New Zealand as part of its inquiry into the Corruption and Crime Commission being able to prosecute its own charges; and
- tabled five reports in both Houses of Parliament.

A summary of the activities of the Committee during the course of this reporting period -1 July 2016 to 30 June 2017 - is in Table 1.1.

## **Chapter 2**

## **Financial statement**

#### **Committee expenditure**

The Committee does not have its own formal budget and is funded out of the budget of the Legislative Assembly. Approval must be sought from the Speaker for major expenditure on a case-by-case basis.

The Committee is required in accordance with Standing Order 276 to detail expenditure for the financial year 1 July 2016 – 30 June 2017. The Legislative Assembly dissolved on 30 January 2017 prior to the state election; therefore two Committees operated during the 2016–2017 financial year. ## **Appendix One**

## Committee's functions and powers

By concurrence between the Legislative Assembly and the Legislative Council, the Joint Standing Committee on the Corruption and Crime Commission was established on 15 June 2017.

The Joint Standing Committee's functions and powers are defined in the Legislative Assembly's Standing Orders 289–293 and other Assembly Standing Orders relating to standing and select committees, as far as they can be applied. Certain standing orders of the Legislative Council also apply.

It is the function of the Joint Standing Committee to -

- a) monitor and report to Parliament on the exercise of the functions of the Corruption and Crime Commission and the Parliamentary Inspector of the Corruption and Crime Commission;
- b) inquire into, and report to Parliament on the means by which corruption prevention practices may be enhanced within the public sector; and
- c) carry out any other functions conferred on the Committee under the *Corruption, Crime and Misconduct Act 2003*.

The Committee consists of four members, two from the Legislative Assembly and two from the Legislative Council.
