## Chair's Foreword

I am pleased to present the Committee's third annual report for tabling. The highlight of the 2022–23 year was the tabling of our report *Hungry for Change: Addressing food insecurity for children and young people affected by poverty*. This was the culmination of approximately 18 months of work for the Committee, on our *Inquiry into the most effective ways for Western Australia to address food insecurity for children and young people affected by poverty*.

This inquiry commenced in April 2022 and set out to find ways to address food insecurity for children living in poverty, while acknowledging that every child has a right to sufficient good food every day. As well as conducting hearings in Perth, Committee members travelled to Albany and Katanning and to remote communities in the Pilbara, Gascoyne and Goldfields. Witnesses made it very clear that the physical problems of under-nutrition and malnutrition can turn into mental health problems and social problems. The ability of students to complete their education or to pursue training opportunities that could lead to employment is compromised, and they remain stuck in the cycle of poverty. The inquiry found that it is time to find a way to break this cycle, but with an ongoing solution, not just quick fixes.

We investigated how food relief and food literacy can assist children experiencing food insecurity. Children need to eat to learn, but they also need to learn to eat. Food relief does not always reach children in need, and its nutritional value is not guaranteed. But without access to good food, lessons on how to prepare good food seem irrelevant. One of the few ways for children to access good food – and potentially to learn about it at the same time – is through a school lunch program. We discovered that a surprising number of our schools are already providing meals and snacks to students from school funds because they see it as a matter of necessity. As one principal told us, it's a 'no-brainer': hungry kids cannot learn effectively.

*Hungry for Change* recommended that WA build on these programs and extend school lunches in an equitable way to mitigate the impact of food insecurity on our next generation. We gathered ideas for how this could be done on a research visit to Tasmania in February and March 2023, where a school lunch program initiated by the canteen association is currently being piloted. We visited some schools in low socioeconomic suburbs of Hobart and saw how much the students appreciated a free, hot, hearty lunch. Teachers and principals at these schools told us how it was making a difference to attendance, and how it had impacted positively on concentration and behaviour. It was extremely valuable to see the school lunch pilot program in action, and it assisted us in making some of the recommendations in our report.

We also heard how Tasmania had implemented a Child and Youth Wellbeing Strategy, which is something the Committee would like to see prioritised in WA. Tasmania has also created a dedicated minister and department for Education, Children and Youth, making it clear where responsibility for child wellbeing lies. Such investment in our children and young people now will pay dividends in years to come.

We received 494 submissions for the inquiry. Around 450 of these were from students who attend Catholic schools across WA, including in some of the most remote areas where the Catholic school is the only school. In addition to our travels around the state, we reached out to members of the multicultural community via two forums held in Mirrabooka, which provided essential insights into the experiences of newly arrived migrant and refugee families. We thank all those who contributed their insights and experiences to the inquiry, especially those children and young people who made themselves heard. Their voices are important, and we included some of their frank and heartfelt comments in the report.

The *Hungry for Change* report was tabled on 22 June 2023, and the government response was tabled on 10 October 2023.

In addition to the Committee's inquiry work, we continued with our oversight role of the Commissioner for Children and Young People. The Committee met with the Commissioner twice during the financial year, and published a review report of some of the Commissioner's activities in March 2023.

I take this opportunity to thank my fellow Committee members for their contributions over the past year: Deputy Chair Hon. Neil Thomson MLC, Rebecca Stephens MLA and Hon. Ayor Makur Chuot MLC. Thank you also to our research staff for their support during the 2022–23 year: principal research officer Dr Sarah Palmer, and research officers Carmen Cummings and Lucy Roberts. Dr Palmer and Carmen Cummings have both now moved on from the Committee, and we welcome Naomi Sherrington as our new principal research officer.

## Other Activities

### YARiC presentation

As part of the Young Aboriginal Researchers in Community project (YARiC), the Commissioner for Children and Young People WA recruited 7 young Aboriginal women aged 12–18 years from schools in the Kalgoorlie area. These students completed training to design and deliver a culturally-informed peer-led research project into wellbeing, mental health, connectedness and gender equity.

The team presented the findings of their draft YARiC Wellbeing Survey report to members of the Committee on 29 November 2022, with the final report due out in June 2023.

### Inquiry engagement process

The inquiry into childhood food insecurity provided an opportunity for the Committee to include the voices of children and young people, who have a right to be consulted on issues affecting them under the UN Convention on the Rights of the Child.

In addition to the actions taken in the previous financial year, the Committee continued to make efforts to reach out to children experiencing poverty, their families and the organisations that support them throughout the 2022–23 period.

The Committee identified that Aboriginal children and young people were at greater risk of food insecurity, and sought their input through recording a 30-second radio advertisement for Aboriginal children with a young voice artist at Noongar Radio. The advertisement was broadcast 64 times by Indigenous stations across the state between August and November 2022. Similarly, the Committee sought to include the experiences of children in refugee and recently-arrived migrant families by attending a briefing with staff at Edmund Rice Centre on 22 November 2022.

The Committee produced easy English versions of the inquiry terms of reference. Catholic Education WA distributed the booklet for children to 7 of its schools. In total, the Committee received 494 submissions, including collated responses representing the views of over 500 Catholic Education WA students from 7 schools across the state. Most submissions were in written form, although some students submitted collages based on the easy English resource. All information provided by children and young people was made anonymous.

Committee members held 25 briefings in the regional towns of Albany, Katanning, Newman and Leonora and the remote Aboriginal communities of Burringurrah, Jigalong and Warburton. These included discussions with Karen youth who attended the Albany Migrant Resource Centre. Investigative travel was also undertaken to Tasmania, to hear about that state's School Lunch Pilot Program and see it in action at three different schools, and to hear about Tasmania's recently implemented Child and Youth Wellbeing Strategy. Eight briefings were included as part of this trip.

The Committee took the large volume of submissions and the testimony of witnesses and participants in briefings across WA and Australia into account to produce the *Hungry for Change* report. A selection of quotes from children and young people’s submissions was included in the front of the report.

Foodbank WA CEO Kate O’Hara reflected on the inquiry process in an ABC Radio interview on 3 July 2023:

The approach taken to this report needs to be commended, because it wasn’t a case of desktop and staying in Perth – it was a case of getting out into community and listening. And whenever a report is brought together based on ‘listen first, write second’, it’s a sensational approach to seeing the Government get informed.

The Committee’s engagement efforts for the inquiry and the feedback received after the report was tabled demonstrate the extent to which the report was informed by the concerns of children, and the community more broadly. The government response to the *Hungry for Change* report is now available on the Committee’s webpage.
